THOR: RAGNAROK (Blu-ray)

Marvel Studios + Disney Home Ent. Marvel Studios' Thor: Ragnarok, the God of Thunder's third installment in the Marvel Cinematic Universe, electrified both audiences and critics alike. Now, the colorful cosmic adventure, loaded with action, humor, drama and spectacle, bursts into homes everywhere.
