One of television's greatest legal dramas, *The Guardian*, returns to DVD for all three of its heart-pounding seasons. Simon Baker stars as Nick Fallin, a handsome hotshot attorney busted on a drug charge and ordered to perform 1500 hours of community service. Just when Nick thought he had lost everything, he found a true calling to help the less fortunate. However, making a difference isn't always easy. Nick is caught between his father Burton, the founder of Pittsburgh's legendary law firm, Fallin & Associates, and Alvin Masterson who runs the firm where Nick follows his passion as a child advocate lawyer.
