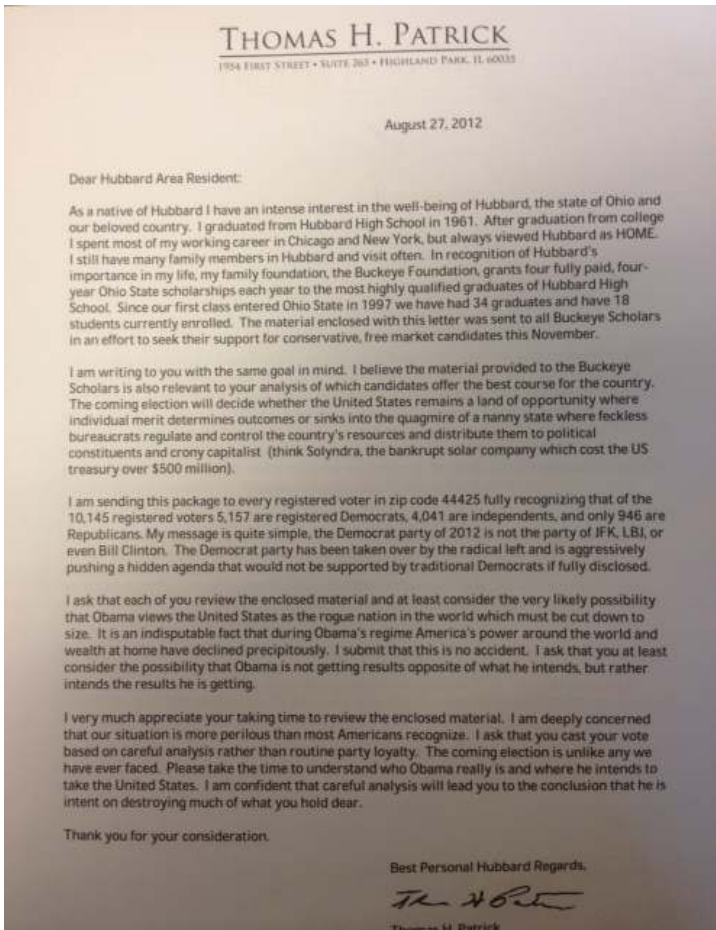

Is this one of the donors who eventually helped promote *Dreams*? I contacted Patrick, but was told he was out of the office, and didn't hear back. When I asked *Dreams* director Joel Gilbert, he reiterated what he'd been telling me as I sent him some annoying

questions: "Thanks for your question, but again, I'm hoping you'll stand out as an unbiased journalist and seriously look at the content of the film, rather than just looking for an angle to dismiss or demonize the film maker."

I. INTRODUCTION

Over most of our country's history, we have been fortunate that the private sector of our economy was so large and productive relative to the size of government that we could endure inept and in many cases corrupt government and still prosper. This is NO LONGER the case. The cancerous tumor of government has grown so large and aggressive that it now threatens to destroy the American system, which is based on free enterprise and individual merit. Government has grown to the point that it now dominates virtually all forms of economic activity, the most dangerous of which is its reckless intervention in the allocation of credit. Government's overwhelming dominance of the mortgage market created massive distortions in credit allocation which created the housing crisis and was the direct proximate cause of the 2008 financial meltdown. In this connection, I have included as Exhibit B, a memorandum entitled "Response Required", which summarizes the major factors that led to the 2008 crash.

Intrusive government is active in every aspect of our lives including freedom of religion. Witness government's attempts to bully the Catholic Church and the Church's resulting lawsuits against the government. We are rapidly approaching a tipping point, which, if passed, will cause the destruction of our country's free enterprise system based on individual merit. The free enterprise system will be replaced by a collective, planned, socialist /communist type system, resulting in destruction of the middle class, and its replacement by one lower class, and one small elite governing class that will distribute the nation's resources as it sees fit.

Many people recoil from this prediction with the simple-minded view that it could not happen in the United States because it has never happened before. It does seem inconceivable, but remember planes flying into the world trade center on 9/11 seemed inconceivable, yet it happened.

II. BACKGROUND

Other than my role as founder of the Buckeye Foundation, I doubt you know much about my family or me. In that, connection I would like to provide a little background that I hope will put my request for help from you in better perspective. I have deep roots in Hubbard, with both sets of grandparents having established residence in the eighteen hundreds. My parents, Ermete and Margurite, lived at the same address in Hubbard for over 60 years, and provided a stable, secure, loving environment for my older brother, sister and me. Among the many lessons they taught us was the importance of personal responsibility, individual initiative and self-reliance. Unlike our current president, they believed that success in life, no matter how defined, depends primarily on determined individual effort. My growth, development and success are a direct result of the application of these principles.

After graduating from Hubbard High School in 1961, I attended Rutgers University on a full four-year scholarship, which was awarded in part because of football and more importantly because of academics. Proof of this assertion is the fact that I never played one play for Rutgers, but kept my four-year scholarship. I graduated from Rutgers in 1965 and then enrolled in the MBA program at the University of Pittsburgh where I received a fully paid fellowship based on my academic record at Rutgers. After graduating from Pitt, I spent two years at Mellon Bank before enrolling in the PhD program at Northwestern, again financed with a fully paid fellowship based on my academic record at both Rutgers and Pitt.

The help I received was granted on the basis of individual merit not government edicts or quotas. Government programs, which virtually always ignore merit and are typically based on some concept of political correctness, result in massive waste and burden productive society with crushing dead-weight cost.

III. BUCKEYE SCHOLARSHIP PROGRAM

By now, you no doubt recognize that my establishment of the Buckeye Foundation was a direct result of my own very fortunate experience of having eight years of higher education awarded to me based on achievement and competitive merit. As you know, the Buckeye Foundation grants fully paid four year scholarships to the very best academically qualified graduates of Hubbard High School. You should be proud to know how very well all of our Hubbard students have performed. Since our initial class enrolled at Ohio State in 1997, 34 Buckeye Scholars have graduated. We currently have 18 students enrolled at Ohio State, and we have had only TWO students leave the program. This is an absolutely astounding result and a resounding testimony to the quality of the Hubbard High School students participating in the program.

At this point I ask you to consider what the results would have looked like had the Buckeye scholarship recipients been selected on some government imposed system based on political correctness rather than academic merit? I will give you a hint: results would have looked a lot like the subprime mortgage market with immense resources squandered for no benefit in pursuit of so-called "fairness".

The fact that the Buckeye scholarships are awarded exclusively to graduates of Hubbard High School reflects my deep love for Hubbard and my appreciation for having been given the opportunity to grow up in a town which, in my view was almost a caricature of the town portrayed in the old TV show "Happy Days", including several residents who were dead ringers for Fonzie Fonzarelli. I think it is critical that you recognize that the Washington, New York, San Francisco elite which controls much of government and academia literally sneers with disdain at towns like Hubbard. In the words of Cass Sunstein, Obama's recently retired regulatory Czar, they view the inhabitants of towns like Hubbard as a whole crowd of Homer Simpsons that must be controlled by government.

As further direct evidence of Obama's disdain and virtual contempt for middle America, we need look no further than his recorded statement to a group of San Francisco Nob Hill elitists regarding our neighbors in Pennsylvania:

"And it is not surprising then that they (a clear reference to us—hard working residents of middle America) get bitter, they cling to guns or religion or antipathy to people who aren't like them or anti-immigrant sentiment or anti-trade sentiment as a way to explain their frustrations".

It is important to understand that Obama did not know he was being recorded and therefore unleashed his real views. Obama agrees with Cass Sunstein and views most Americans as really nothing more than childish "Homer Simpsons" to be manipulated as pawns in his class warfare game.

You must recognize that Obama is a master at class warfare and that the class which inhabits the Hubbards of the country is far down his list and will be severely disadvantaged by the continued growth of government. IV. (a) OBAMA ENERGY POLICY

You are no doubt aware that growing exploration and development of natural gas has provided the first significant capital investment in northeastern Ohio in over 40 years. Vallourec SA, a French company recently opened a \$600 million seamless pipe plant in Youngstown. Obama has been trying to spin (or as journalists now say "walk back") this statement for weeks to no avail.

The Roanoke speech is Obama's emotional, bald indictment of the value of individual effort and is an attempt to lay the groundwork for broad scale confiscation of private property based on the false premise that "you didn't build that, somebody else made that happen" so we can take it from you.

VI. CONCLUSION

The education I was privileged to have was foundational in allowing me to take advantage of the economic freedom we have in America. My education, combined with hard work, and determination, have enabled me to experience the American Dream. My success has allowed me to fund the Buckeye Scholarship Program, which has given all Buckeye scholars that same opportunity. What you make of your life after college is up to you!
