Some respond by demanding more police while others at the same time say they oppose a police occupation for their communities. Preachers preach from pulpits about love and respect but the violence continues. Actions always speak louder than words, especially if the words are being preached to the choir.

Back in 1965. Daniel Patrick Moynihan authored a report on black family disintegration and things have grown so much worse in a half century. He called what was happening a pathology afflicting African Americans. Moynihan "saw the break-down of the nuclear family as the fundamental source of weakness in the black community." Today that Today that pathology has spread across all racial lines

We see clearly today that far too many men of all races have abdicated their responsibilities as fathers and providers. If society doesn't find a way to reverse this social decay, we will only keep repeating the past generation to generation. This breakdown by men cuts across the race line but it still seems unfortunately too visible in many black families

Several years ago. one June day with Father's Day quickly approaching, I was over at the Grove Hall Mecca at CVS Pharmacy looking for a nice Father's Day card for co-worker. I was having trouble finding any. I asked a store worker who then told me. "Go down to the end of that aisle. There are some down there." I did as he said and found four different Father's Day cards. All pretty ugly. I went back over to the young man and asked if there were any other cards and he told me, "I'll be surprised if we sell any of those four cards."

Supply and demand. Sad isn't it. The answer about the violence is the answer about the breakdown in family life. When our leaders

start dealing with the break-down in society, we will deal with the cancerous violence tearing away at our commu-nities. Until then, we can only react to the carnage.

To change what was identified a half-century ago will take more than sound-bites by politicians, panel discus-

sions and written reports I believe that 1965 Report by James Patrick Moynihan on the "pathology" he observed within black communities eventually spread to the entire structure of all family life in America. We should have moved on his observations with effective public policies that could
