Binge by viewing the six discs that comprises the complete series of SEE. After a deadly virus centuries ago, humanity lost the ability to see. Vision is now a myth. In a hidden mountain village, twins are born to the family of Baba Voss (Jason Momoa) with sight, disrupting the kingdom's balance. Hunted by a ruthless queen, the twins and their family embark on a perilous journey that could change everything. In Season two, Baba Voss is fighting to reunite his torn-apart family and get away from the war and politics that surround him, but the more he moves away, the deeper he gets sucked in, and the emergence of his nemesis brother Edo, threatens his family even more Nearly a year after defeating his brother Edo, Baba Voss (Momoa) lives alone in the forest. When a Trivantian scientist creates a devastating sighted weapon that threatens humanity, Baba returns to Paya to protect his tribe once more.

# RUST (Blu-ray) Decal Releasing

The film Rust, starring Alec Baldwin, has been released on Blu-ray by Decal Releasing. The story follows a 13-year-old boy, who was left to fend for himself and his younger brother. following the death of their parents in 1880s Wyoming. They are taken on a harrowing journey to old Mexico by his long-estranged grandfather, after he's been sentenced to hang for the accidental killing of a local rancher, with a US Marshall and a vicious Bounty Hunter in pursuit. This home entertainment release follows a limited theatrical run. The movie was completed after a tragic on-set incident and is being released to showcase the work of the late cinematographer, Halyna Hutchins. The release of Rust has been a long and complex process, beginning with the on-set shooting of Hutchins that occurred in 2021. The film was completed after a settlement was reached with Hutchins' family and with the goal of honoring her work. Decal Releasing is handling the home entertainment distribution, while Falling Forward Films is managing the limited theatrical release. The theatrical release began in May, with a debut at the film festival in Poland in November 2024.

#### HELL OF A SUMMER (Blu-ray/DVD) Decal Releasing-Neon

Decal Releasing, in association with Neon, brings to Blu-ray Billy Bryk and Finn Wolfhard's Hell of a Summer (2024), starring Fred Hechinger, Finn Wolfhard, Abby Quinn, Billy Bryk, and Matthew Finlan. Blending the suspense of classic horror with

the irreverence of coming-ofage comedy, Hell of a Summer brings a fresh perspective to the summer camp horror genre. Dubbed Friday the 13th meets Wet Hot American Summer, the film nods to the classics while carving its own path. The film follows Jason Hotchberg (Hechinger), a 24-year-old camp counselor that feels out of touch with his teenage co-workers. What he doesn't know is that a masked killer is lurking on the campgrounds, brutally picking counselors off one by one.

Wolf and Dog, the debut feature-length narrative from Portuguese documentarian Claudia Varejão, is a poetic coming-of-age drama set in the deeply religious and traditionbound island of São Miguel in the Azores. The film follows Ana, a young girl whose close friendship with Luis — a boy who freely embraces both dresses and pants — begins to challenge her perceptions of identity and the rigid world around them. When Ana's friend Cloe arrives from Canada, their journey into the local queer community opens new possibilities for selfdiscovery and freedom. Against the backdrop of a working-class town where adults expect youth - becoming farmers, fishermen, or mothers — the film explores the struggles of queer teenagers yearning to build their own community and redefine traditional notions of masculinity and femininity. Through a blend of gritty realism and striking visual poetry, Wolf and Dog, is a heartfelt and visually stunning film that transcends conventional portrayals of reality, reflecting a broader message about shifting cultural perceptions and embracing change.

On Tuesday, August 5th, I took a walk down to LoPresti Park on the other side of Sumner Street down by the Reel House for the annual East Boston National Night Out celebration. As a retired police officer of 28 years with the Metro Boston Area DMH Police, I always attended this annual event. Been going to it for years and the uniting power it generates between all who call Eastie their home. We are always safer when working together to improve our daily lives.

I bumped into a fellow long-time community journalist Frank Conte at the event. Over a good 40 years now the both of us have reported on local stories which impact us the most. Housing has always been one of those stories but the most important story is the ways in which we as a community work to make, in this case, East Boston the best it can be.

Frank recently wrote something that says it all about the idea of community policing, "true community policing requires two-way trust and collaboration. East Boston is better at demonstrating how local law enforcement engages with the community."
