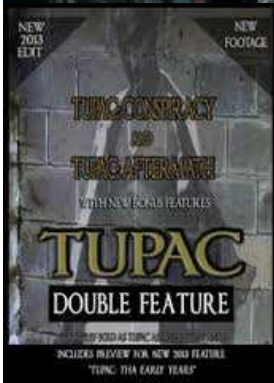
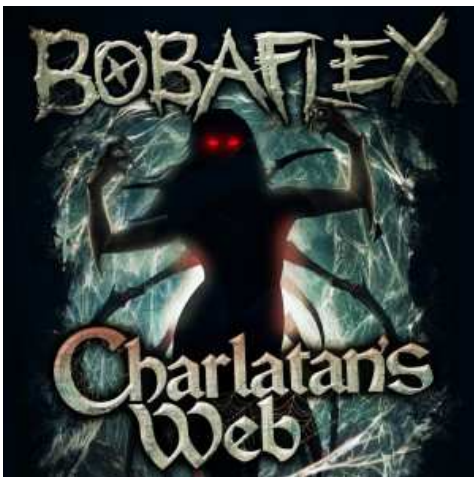

DVD Feature Review: 2Pac – Two Pack: Conspiracy and Aftermath

Last Friday, 13th September marked the seventeenth anniversary of the passing of rapper, Tupac Shakur. Nearly twenty years on, his music continues to sell, his image can be seen emblazoned on posters and T-shirts, and yet his murder remains unsolved.

This two-DVD collection aims to lift the lid on the investigation, how the facts of Tupac's death were presented to the public, and who may be responsible for the murder of one of music's biggest icons. The two films bring together testimony from those who were there on that fateful night in Las Vegas, Tupac's family members, those who knew him, former police investigators and more to create an intriguing picture. Both films have previously seen release as 'Tupac Assassination I & II,' but they have been fully updated for 2013, with new footage.

'Conspiracy' looks at the details surrounding the death of Tupac Shakur to demonstrate the disparity between the information that was made public, and the apparent truth of what happened on the night of the shooting that ultimately claimed Tupac's life. 'Aftermath' takes its lead from 'Conspiracy' and, as such, is forced to go over some of the same ground, except this film goes further into what happened in the days following Tupac's death.

Aside from offering eye-opening information that seems to link people associated to Tupac's record label, Death Row Records, to the murder, this collection also serves to uncover what appears to be gross negligence by some of those tied to the investigation. It is shocking to see how the film-makers can seemingly make inroads into the investigation that detectives failed to, including a failure to interview key witnesses.

This collection is required viewing for any fans of Tupac Shakur, as well as those who are intrigued as to how one of the biggest names in rap music can get murdered in Las Vegas, and yet the case remains unsolved. Full of shocking revelations, this double pack offers engrossing viewing – you truly won't believe how simple the alleged truths of these movies are!
