BAKER'S SWITCH ON MASS HEALTH?

In her recent Boston Globe commentary, Joan Vennochi was pretty critical of Governor Charlie Baker's decision to remove 140,000 nondis-abled adults age 21 to 64 from MassHealth, the state's Medicaid program, to commercial insurance through the Commonwealth Connector. They would have to pay premiums like the rest of us and be responsible for co-pays also like the rest of us. However, House Democrats are opposed to this reform proposal.

Something has to be done with Medicaid, as it has been expanded again and again until the price tag now amounts to 43% of the state budget*. according Vennochi's commentary. Democrats are crying the usual refrain about how the governor wants to balance the budget on the backs of the

working poor.
When first implemented, Medicaid had strict eligibility benchmarks to reach. As more and more are added to the MassHealth rolls, soon that program could represent nearly 50 percent of the budget and who knows when it makes the push over that mark. It's at a tipping point now. To do nothing, like liberals want, is simply irrational.
