Warfare is a war film based on a real mission in an al-Qaeda controlled area of Iraq's Ramadi Province. The film revolves around a U.S. Navy SEAL platoon's surveillance mission in insurgent Iraq territory, while in the home of an Iraqi family. The group of American Navy SEALS were surveilling an urban residential area to make sure that ground troops could pass through safely the next day, which unfortunately quickly escalated into a dangerous firefight.
