North Square is Where the Giarratani Family was Reborn in America

As a member of the North End Historical Society, I have been receiving a great number of emails, one recent one contained a number of very old photographs going back about a century. A particular photo caught my eye almost immediately. I have only viewed this photo once or twice before.

About eight or so years ago after connecting up with my cousin Frank down in Pittsburgh, we started putting some of the pieces of the Giarratani Family puzzle together. He located the house where our mutual grandfather lived which was also the birthplace of his father. That address on Moon Street was also where our paternal grandfather passed away

My research uncovered the first address of the Giarratani family in America. It was right in North Square at the fork in the road to North Street. When I looked at the photo from Tommy D. I recognized it as the site of my grandfather's first flat in America. I think I remember finding out it was on the third floor. You can see it so clearly in this old photo. Today, it is part of the Paul Revere House

grounds. When I write about my Giarratani family, I must write about the Assenza family too which had settled on Fleet Street in the mid-1890s. My grandmother was an Assenza and it appears her brother, already settled in the North End, was the immigration spon-sor for my grandfather's entry into America

My grandfather left the Old Country for America in 1906 and arrived in East Boston at the immigration station and settled near the Assenza family. They were all from Sciacca in Agrigento, all "scaccatons' down to the core. Neither family were fishermen, but farmers. Hey, someone needed to add potatoes and veggies to the plate, right?

I was so glad to see the photo of North Square and the long since demolished building that was the first home for my grandfather after making that long trip in steerage on the

Dante Manghetti.
By the way, I am still looking for an old photo of that steam-liner that ended up in the Port of Boston. I have no idea how long the passage took or what my grandfather thought of Boston at first sight.
